## TERMS AND CONDITIONS

The Los Angeles Convention Center (LACC) parking fee is \$12.00 per day and does not include in and out privileges.

## A. PARKING CARDS REQUIREMENTS AND CONDITIONS FOR USE:

- 1. Parking passes are available for Exhibitors at \$25.00 per day.
- 2. Parking passes are valid only during dates indicated on this form. Parking card automatically deactivates and is void at 12:00 a.m. (midnight) on last day.
- 3. Exhibitors with pre-ordered parking pass must still pay a one time \$12.00 parking fee to gain access into the parking lot. Please present your parking entry stub to Exhibitor Services Desk when obtaining your parking pass or credit **cannot** be given.
- 4. Refunds cannot be given for unused days.
- 5. Parking passes are not transferable. Activity use of parking passes are monitored at all times. Misuse such as using card for more than one vehicle to enter will cause your parking pass to be deactivated.
- 6. If you experience any malfunctions while using your parking pass, please return to the Exhibitor Service Desk for replacement.
- 7. Single parking pass allows one parking space. Oversized vehicles which occupy more than one space must obtain additional permits.
- 8. 24 hour parking is not allowed without the consent of the LACC and are subject to immediate removal at owner's expense.
- 9. Any vehicle parked illegally and left beyond the parking time <u>LIMIT</u> will be subject to a ticket violation and removal at owner's expense.
- 10. Please lock your vehicle and place valuables out of sight.
- 11. A \$35.00 service fee will be charged for all returned checks.

## B. LACC LIMIT OF LIABILITY

- 1. The management declares itself NOT RESPONSIBLE FOR AND ASSUMES NO LIABILITY arising from fire, theft, damage to, or loss of the vehicle or any article left therein.
- 2. Only rental of space license is granted hereby and NO BAILMENT IS CREATED.
